We provide payroll and accounting services, administer CCMBC's national group health insurance and pension plan, and offer lending and investment services through our wholly owned subsidiary CCMBC Investments Ltd. Investment and lending activities are provided through Legacy's subsidiary CCMBC Investments Ltd. By investing in promissory notes, our investors provide the capital necessary for us to extend secured mortgages to our churches, pastors, schools, and camps, enabling them to have a presence in the communities they serve.

About the Role

Reporting directly to the Chief Financial Officer, the Controller has the following primary responsibilities:

- Leading and overseeing the activities of the accounting department.
- Handling Financial Reporting, Budgeting, and Internal Controls.
- Spearheading automation projects of the Finance department and other process enhancement initiatives.

Key Responsibilities

- Leadership and Supervision:
 - Effectively manage the day-to-day activities of the Accounting team, including maintenance of the General Ledger, Accounts Payable, Accounts Receivable, and Cash Receipts.
 - Provide leadership and mentorship to the Accounting team, ensuring appropriate training and development opportunities.
 - Implementing and supervising accounting procedures and processes.

- Financial Reporting, Budgeting, and Internal Controls:
 - Ensure timely completion of internal financial statements for CCMBC Investments, CCMBC Legacy Fund, and associated/related entities in accordance with the relevant accounting standard framework (IFRS, ASNPO or ASPE).
 - Ensure timely completion of all internal and external financial reporting.
 - Administer the annual budgeting process including revenue and expense forecasting.
 - Ensure the adequacy of internal controls over financial reporting and processes.
 - Ensure regulatory and tax compliance with government requirements.
 - Plan and coordinate the preparation for the annual audit and liaise with external auditors.
