
Interest Rates

"God spoke very clearly to us about this move," commented Ian, "God said, 'I'm going to root you somewhere.' And that was something we'd been longing for: to feel like we belong somewhere, that we could put down roots." Owning a home—a place to raise a family—represented tangible evidence of God's plan. Upon recommendation from a local pastor, Ian and his family reached out to CCMBC Legacy Fund for help.
